# Project status

- WP1: Difficult to understand the purpose of the glossary.
  - It's a bit rough list at the moment
  - We discussed the purpose, and the audience, so that we prioritize the time in the project
    - AC and ML will discuss how to define the purpose, audience etc and how to prioritize and organised
  - SY: expressed interest in contributing
  - HS: a similar effort in EOSC-Nordic proved very helpful, suggested a hackathon
  - ML: suggested we look at this from the perspective of semantic interoperability
- WP2:
  - RM: Suggestion that it's worth waiting a bit before starting Task 2.2 because of events from other initiatives and D2.1 is only due in M12.
